PROPOSAL DOCUMENTS

Below is a list of required documents to submit a complete proposal to our Board of Governors for review (Inquiry and Endorsement Forms are contained in this packet):

1 INQUIRY FORM This is for the prospective member to fill out. It contains general contact and background information.

1 LETTER OF RECOMMENDATION (THERE IS NO FORM FOR THIS) This would come from the "Proposing Member". A letter or email is sufficient and should contain any information you feel would be relevant to our Board in making their decision to extend or decline the invitation of membership.

- Proposing Members can be any current member of the Club, of any membership classification.

2 ENDORSEMENT FORMS This is for two current members, other than the Proposing Member mentioned above, to each fill out.

- If Proposing a Junior Prospect: Endorsers must be in the Junior, Resident or Honorary Life categories.
- If Proposing a Prospect of any other category: Endorsers must be in the Resident or Honorary Life categories.

Once these 4 documents are secured, please send to Marketing Director, Casey Nichols: membership@thefyc.org or drop off at the Front Office, Attn: Casey Nichols.

The proposal process requires two approvals by our Board of Governors, known as Readings. All documents referenced above must be received prior to a First Reading.
